POWER OF ATTORNEY FOR MR. ALEKBAROV FIRDOVSI. 2026/01/06

By the decision of the Administrative Council of the "Comité International pour la Protection des Droits de l'Homme" (International Human Rights Defense Committee), hereinafter referred to as the "CIPDH", with a view to the development and strengthening of the organization's international presence and activities directed toward the achievement of the authorized goals and objectives of CIPDH,

Mr. ALAKBAROV FIRDOVSI (citizen of the Republic of Azerbaijan, Passport No. C02312733, issued by the Ministry of Internal Affairs of the Republic of Azerbaijan, date of issue: 15.11.2018, date of birth: 02.11.1951) fulfilling the obligations of the Director of the Financial Department of CIPDH and authorized representative of the organization, is hereby granted the following authorities and powers:

Scope of Authority

The Administrative Council of CIPDH hereby authorizes **Mr. ALAKBAROV FIRDOVSI** to:

- 1. Promotion and Representation of CIPDH Activities:**
 - o Promote the activities and development of CIPDH in the Republic of Turkey;
 - o Represent the interests and objectives of the CIPDH in all governmental, state, and public structures within the Republic of Turkey
 - o Conduct all necessary negotiations on behalf of CIPDH within the scope of international cooperation
- 2. Establishment and Registration of Structural Divisions:**
 - o Carry out registration and establishment of structural subdivisions of CIPDH, including branch offices and representative offices, within the jurisdiction of the Republic of Turkey;
 - o Execute all necessary legal documentation and administrative procedures required for such registrations;
 - o Enter into agreements and contracts on behalf of CIPDH with relevant Turkish governmental and administrative authorities;
- 3. Personnel Management and Consultation:**
 - o Recruit, select, and appoint qualified personnel for the organization's operations;
 - o Provide professional consultation and guidance to organizational staff members;
 - o Manage human resources matters in accordance with CIPDH policies and applicable Turkish labor laws;
- 4. Document and Financial Authority**
 - o Store, transfer, withdraw, and manage all types of CIPDH internal service documents and organizational identity documents
 - o Manage financial matters related to the aforementioned authorities

5. Validity and Limitations

- Validity Period: This Power of Attorney is valid for five (5) years from the date of signing
- Non-Transferability: This Power of Attorney cannot be transferred, delegated, or sub-delegated to any other person
- Plenipotentiary Status: The Administrative Council of the "International Human Rights Defense Committee" confirms the full authorities of Mr. ALEKBAROV FIRDOVSI as plenipotentiary representative of CIPDH within the scope of this document
