POWER OF ATTORNEY FOR Mr. OMAR SAID. 2025/12/13

The Administrative Council of the **International Human Rights Defence Committee**
(*French: Comité International pour la Protection des Droits de l'Homme – CIPDH*)
with registered address at **6 rue du Docteur Finlay, 75015 Paris, France,**

hereby **appoints and authorizes:**

to act as its **true and lawful Attorney-in-Fact**, with **full power and authority** to represent, act for, and bind the **CIPDH** in the **Islamic Emirate of Afghanistan**. The Attorney-in-Fact has no authority to perform any actions involving CIPDH funds, bank accounts, cash, securities, real estate, movable property, business interests, or any other financial or property rights, including but not limited to opening, closing, or managing accounts; disposing of property; entering into transactions that create financial obligations; or receiving or handling funds on behalf of CIPDH.

Scope of Authority

The Attorney-in-Fact is hereby expressly authorized to:

1. **Represent CIPDH** before all Afghan authorities, including but not limited to:
 - Ministries
 - Departments
 - Courts
 - Municipal and local authorities
 - Security and regulatory bodies
2. **Conduct negotiations** with governmental, non-governmental, and international entities related to CIPDH activities in Afghanistan.
3. **Sign, execute, amend, and terminate:**
 - Memoranda of Understanding (MoUs)

- Cooperation agreements
 - Letters of intent
 - Official correspondence
 - Any other documents necessary to carry out CIPDH's mandate
4. **Register, establish, and manage** CIPDH representation, projects, or offices in Afghanistan, including dealing with licensing, accreditation, and compliance matters.
 5. **Appear before courts and legal bodies**, appoint legal counsel where necessary, submit documents, and take any lawful action required to protect or advance CIPDH's interests.
 6. **Make and receive proposals**, agree on terms and conditions, and perform all lawful acts necessary or incidental to the execution of this Power of Attorney.

General Provisions

- This Power of Attorney is **non-transferable** and granted **exclusively** to the above-mentioned individual.
- The Attorney-in-Fact shall act **within the laws and regulations** applicable in Afghanistan and in accordance with CIPDH's mission and objectives.
- This Power of Attorney shall remain valid **until revoked in writing** by the Administrative Council of CIPDH.
